

We respond to *over 100 requests for service each day*, making us the busiest EMS provider in the county.

We operate from **11 different locations** providing advanced life support (ALS) and basic life support (BLS), wheelchair van, specialty and bariatric patient transportation services and a proactive team of Community Paramedics. We also offer medical standby coverage for events and a variety of educational services for both healthcare professionals and community members.

# Bur History 25 YEARS OF GOLD STANDARD CARE

### On April 28, 1996 at 0700 hours Lancaster EMS became operational.

This year, Lancaster EMS—also known as 'LEMSA'—celebrated its 25th anniversary. Our story began on February 27, 1996 when LEMSA was first incorporated as a nonprofit 501 (c) (3) emergency medical services association. This was the result of a consolidation between the Advanced Life Support (ALS) of St. Joseph Hospital (SJH) and the Community Hospital of Lancaster (CHL).

The bold idea of joining two competing, hospital-owned ALS departments to form a private, not-for-profit ambulance service was brought forth by Bob May and Dave Bradley. At the time of the consolidation discussions, Bob was managing EMS and the Emergency Department at CHL and Dave was managing EMS at SJH. At the time of the new company start-up, Bob was appointed Board Chair and Dave became the Operations Manager for Lancaster EMS.

On April 28, 1996, the new agency became operational. With five stations across Lancaster County, LEMSA was responsible for providing 9–1–1 ALS service to eighteen municipalities. Today, Lancaster EMS is one of the largest, most unique not-for-profit EMS organizations in the county, serving over 260,000 community residents across 21 municipalities. Bob still retains his leadership role as the Executive Director for Lancaster EMS, while Dave is now a Senior Risk Solutions Representative for Glatfelter Insurance.

Lancaster EMS has spent the last 25 years supplying gold standard care to the Lancaster County community; we aspire to do so for many more years to come.


Lancaster EMS has received reaccreditation from the Commission on Accreditation of Ambulance Services (CAAS) for its compliance with national standards of excellence. The original accreditation was obtained in 2005.

The review process for accreditation includes completion of a comprehensive application and on-site review by national experts in emergency medical services (EMS).

Lancaster EMS is the <u>only</u> ambulance service in Lancaster County to earn this achievement, and just 1 in 5 to be accredited in the state of Pennsylvania.

### Service Area Map



#### Did You Know...

- Lancaster EMS serves over 260,000 community members across 21 municipalities, making it one of the largest nonprofit EMS agencies in the county
- We have 11 stations across Lancaster County
- In 2021, Lancaster EMS responded to over 43,000 requests for service

Red shaded areas are within our ALS coverage area. Blue shaded areas are within our BLS and Membership coverage area. The overlapping areas that appear purple are within both our BLS and ALS coverage area. Advanced Life Support (ALS) is a level of care for patients who are facing lifethreatening illness or injury. Basic Life Support (BLS) is a level of care for patients who are experiencing medical conditions that are not life-threatening. Pins signify our station locations.





# OUR MEMBERSHIP

#### SERVING LANCASTER COUNTY FOR 25 YEARS

We remain committed to providing the very best equipment, technology, and highly trained professionals for resident's healthcare. Our efforts and readiness come at a high financial price.

We receive no direct tax dollars.

#### We rely on those that we serve for support.

For our members, we wave unpaid out-of-pocket expenses for all emergency medical services balances after we receive payment from the insurance company (excluding deductibles and unauthorized discounts). If the patient doesn't have insurance or if their insurance denies the charges, we give a 20% discount on emergency service charges. Our members receive a 20% discount for CPR certification classes. Members also receive a 20% discount for wheelchair and non-emergency transport services.

# EMS IN CRISIS

# What if you called 9-1-1, but EMS wasn't there to respond?

# Our future is directly dependent on the support we receive from the very same communities we serve.

Emergency Medical Services in many locations across the United States are in crisis. Lancaster EMS-- like most EMS agencies in Pennsylvania, are struggling with recruiting and retaining personnel. In addition, agencies are not fully reimbursed by Medicare/Medicaid for the life-saving services being provided.

#### When it comes to Lancaster EMS, you may be surprised to learn that:

- Lancaster EMS does not receive direct tax dollars. Our funding is received through Fees for Services (86%), Investment Revenue (4.6%), Grants/Donations (2.4%), Ambulance Membership Subscriptions (3.7%), Training (1.7%) and Municipal Support (1.6%).
- Reimbursement from Medicare/ Medicaid cover less than half the cost of the life-saving services that we provide.
- Some Pennsylvania EMS patients receiving commercial reimbursement for 9-1-1
  medical services do not forward payment to the ambulance agency that provided
  the service.
- For many nonprofit, private ambulance providers, EMS wages and retirement benefits **are not** commensurate with Police and career Fire services.






"911 Emergencies" Include: Ambulance Dispatches by the 9-1-1 Center

# EDUCATION

#### Community Outreach



As a part of our mission to uphold the wellbeing of the general public, Lancaster EMS participates regularly in a wide variety of community outreach events. At these events, our staff performs medical demonstrations, offers tours of our ambulatory vehicles, and talks in-depth about what the world of EMS entails.

#### **AHA Courses for Healthcare Providers**

Lancaster EMS is an authorized training center that hosts several courses for healthcare professionals: BLS/Heart saver Instructor Course, ACLS, BLS and CPR, PALS, and PEARS. These courses are designed primarily for healthcare professionals in emergency departments, intensive care units, critical care departments, surgical areas, or pre-hospital environments, such as physicians, nurses, paramedics, respiratory therapists, and other professionals who may respond to medical emergencies.

#### Heartsaver CPR/AED/First Aid

Heartsaver CPR is a classroom course that teaches basic CPR skills such as performing a head tilt-chin lift, giving compressions and breaths, and calling your emergency response number (or 911). The program teaches Adult/Child CPR, Adult/Child Choking, and offers optional modules in Infant CPR and choking, Adult/Child CPR with mask, and Infant CPR with mask. Additionally, the course covers the proper usage of an Automated External Defibrillator (AED).




#### Paramedic Program

Our paramedic program is a collaboration with Pennsylvania College of Health Sciences. Experienced paramedics, pre-hospital registered nurses, and physicians lead students through lectures, skill sessions, and clinical/field training. Upon successful completion, students are eligible to take the National Registry of Emergency Medical Technicians Paramedic Certification exam.



# LEARN WHILE YOU EARN Education today to save a life tomorrow!



Lancaster EMS now offers a PA Bureau of EMS approved EMT-Basic Certification Course. This program is a collaborative effort with PA CareerLink.



Eligible candidates are being hired as Full-Time Lancaster EMS employees and compensated a training wage of \$15.00/hour and work a minimum of 40 hours/week. Upon successful completion of the program and after obtaining their PA Bureau of EMS certification, the employee will be promoted to EMT-Basic with the commensurate pay increase to \$19.00/hr. and associated benefits. The candidates also agree to a 24-month commitment to Lancaster EMS post certification.

# LANCASTER EMS IS SENSORY PREPARED



We have partnered with Schreiber Pediatric to become the 1st EMS Agency in Lancaster County to equip 30 of our front-line ambulances with sensory bags. The push for change came from Lancaster EMS, EMT Saranika Griffith, who also happens to be a mother to a five year old boy with Autism. She brought the idea to Marisa Seubert, Director of Marketing & Development who then passed it along to Schreiber.

Schreiber received a \$5,000 grant from the Clark Family Foundation that paid for 150 sensory bags along with the complete supply of sensory items, which included headphones, stress balls and sensory necklaces. Our providers use these sensory bags on calls to help children with autism or other behavioral or anxiety issues to feel more comfortable.

Lancaster EMS Community Paramedic, Katie Miller-Amick--another mother to a child with special needs--also provided input on the idea. "It's a really good tool for us to have," she said, "It might not be an everyday situation, but when it does happen it's important for us to respond in a way that creates a positive experience for those patients."

# COMMUNITY PARAMEDIC

#### New Parent Program

Lancaster EMS has developed a program dedicated to families with newborns. The New Parent Program, taught by Community Paramedics, covers topics such as SIDS Education, Heartsaver CPR/Child & Infant Choking, Shaken Baby Education, and Febrile (fever) Seizure Education. Each New Parent Program is catered to each parent's individual needs. Our highly skilled paramedics offer to do appointments in-home or allow for parents to schedule an appointment to come to one of our stations.

#### Shower Trailer

In partnership with LancCo MyHome (Lancaster County Homelessness Coalition), Lancaster EMS launched a mobile shower trailer. The trailer is outfitted with 2 shower stalls and a Community Paramedicine office. It offers hygiene and medical services, minor wound care, vaccinations and health related education to unhoused individuals in Lancaster City and surrounding areas. This service is free of charge to patients with hopes to fill gaps in care.

### Administered 2,144 Vaccines

Lancaster EMS was the 1st EMS agency in the Commonwealth of Pennsylvania to receive authorization from the Department of Health to administer the COVID-19 vaccine.

We received our first shipment of the Moderna COVID-19 vaccine on January 14, 2021, and began vaccinations four days later on January 18, 2021.

In conjunction with performing vaccinations at our Lincoln Highway Station, Lancaster EMS also reached patients through remote clinics and by performing in-home vaccinations.

Lancaster EMS is committed to maintaining the wellbeing of our community, and that didn't stop with the pandemic.

#### What We Do...

Our Ride Along Program provides a comprehensive overview of the Emergency Medical Services process from 9-1-1 dispatch to patient handoff to a hospital emergency department. We will offer an educational overview of our life-saving medical equipment, select medications, vehicle and station tours, and a tour of an emergency department. You will witness our professional and caring providers respond to emergency calls firsthand.

## Ride Along Guidelines

- You will be given a lanyard ID badge to wear at all times. You may also be required to wear a safety vest (provided) if exiting the vehicle on a roadway incident
- As a VIP guest, you will be limited to strictly observing. Photography/Videography recording of patients during observation is strictly prohibited
- Lancaster EMS crew will review scene protocol to assure your safety and security
- We may ask your approval if we share a photo of your experience on our social media platforms and website
- Before you may participate in the program, we will ask you to sign a release of liability

In 2020, Lieutenant Nate Shorter of Lancaster EMS had been named ALS Practitioner of the Year!








# Governor Wolf Visits Lancaster EMS
